RENOUNCED THE KING

Oscar O. Knight of Bengal, is the first in Clinton County, and among the first in the state, to renounce allegiance to King Edward VII. Mr. Knight has lived in this country 23 years. Two years ago the ninth of last November he took out his first papers preparatory to becoming a full-fledged citizen of the United States, stating that it was his bona fide intention to become a citizen of the United States and to renounce forever allegiance and fidelity to each and every foreign price, potentate, state or sovereignty whatsoever and particularly, Victoria, Queen of reas Britain and Empress of India of whom I have been a subjuect.

Thus far only one candidate has developed for sheriff Ex-supervisor, Wm. Schavey of Watertown. M. S. Doyle and Levi Partlow are candidates for the legislature, E. C. McKee, Victor, Hayes L. Burch, Lebonon and DeWitt, H. Hunt, St. Johns, are candidates for county clerk; Syrel Parmenter of Ovid, Robert Armour, Duplain, Herbert Collister, Bath, are said to be candidates for register of deeds, and

Edgar Burk, of Greenbush, had also been mentioned in that connection. Dwight Morrison of Greenbush and Ed.Lyon of Bengel are mentioned for treasurer; Judge Charles M. Merrill for Judge of Probate; S. Reece Smith is a candidate for renomination as prosecuting attorney and Lewis Severence is also a candidate. There are probably other candidates for the various offices who will come forward.
