Scott comes back

Son of famous St. Johns doctor

Edwin Scott, of White Plains, N. Y., returned to St. Johns for his 50th high school reunion and visited Paine-Gillam-Scott Museum, his childhood home.

"He told how he and his brother, Robert, put windows in the back room porch so they could sleep there in the summer," Catherine Rumbaugh, PGS director, said.

She said Scott's recollections revealed PGS staff were quite accurate in restoring the house.

The room now used to house a "doctor's room" exhibit to honor the three doctors who occupied the house, was Edwin's bedroom. It was smaller, he said, as two rooms were later made into one. He donated a Hitchcock chair that belonged to his father's Camden, Ohio family; a pitcherstein of his mother's; a medical paper written by Dr. Gillam; and a history of businessmen and homes in St. Johns written in the 1890's.

Edwin is the son of the late Dr.Walter and Malinda (Brady) Scott.
